

**Tax Year-2025 e-filing** will start on **February 23, 2026**

Please bring the following documents (**Only those apply to your tax situation**)

1. T4 (s)
2. T5 (s)
3. T4E
4. T4As, T4A(P), T4A (OAS), T4RSP, TFHSA
5. T5007
6. T5018 (for contract payments)
7. T2202 (For Tuition fee)
8. T2200 (For Employment Expenses)
9. **Child Care expenses** (please bring invoice from Day Care/School Supervision)
10. Donations (Donations can be carried forward for up to five years)
11. Student loan interest (You, or a person related to you can claim for the preceding **5 years**)
12. **Medical Expenses** (if these are more than 3% of your income).

**Your pharmacist(s) can print a summary of medical expenses for everyone in your family**

13. Moving expenses

If you moved from some other city during 2025, you could claim moving expenses. Bring all the details of expenses you want to claim.

15. Home Office Expense (Based on the proportion used for employment)
16. First time home buyer amount-A credit of \$10,000 (**Max Tax Benefit of \$1,500**)
17. **Self Employed Business/Rental/Air BNB/Taxi (Uber/Uber Eats/Door Dash etc.**
  1. Please bring detail of Revenue from all sources (calculate a total amount for each category).
  2. Uber/Uber (EATS)/Door Dash/Skip the dishes (Company issues a slip for the year, please bring that slip)
  3. Details of all expenses (calculate a total amount for each category).

**For Motor Vehicle Expenses you need to bring following information**

- 1 Make, Model and Year.
- 2 Date of Purchase of vehicle.
- 3 Purchase Price.
- 4 Number of Kilometers travelled in whole year.
- 5 Number of kilometers travelled for the employment.
- 6 Detail of Motor Vehicle Expenses. (Gas, maintenance, insurance etc.)

4. Detail of Motor vehicle expenses (calculate total amount of expenses you want to claim)

**You need to file a GST return if you are already registered. Please bring GST Access Code**

**18. For Home office expense, you can claim the following:**

Electricity, Heat, Water

Maintenance and minor repair costs

A portion of rent/mortgage interest paid for a house or apartment where you live

**If you make commission as part of your salary, you can also claim:**

Home insurance, Property taxes

Equipment—such as cell phone, computer, laptop, tablet and/or fax machine—related to your commission income

**Deadline:**

Deadline to file your tax return and pay your taxes is **April 30, 2026**.

If you're **self-employed** or have a spouse or a common-law partner who is self-employed, the deadline to file your taxes is **June 15, 2026**.

All tax amount owing must still be paid by **April 30, 2026**.
